**NOTES:**

1. The ADDITIONAL DAY FEE will commence on the 6<sup>th</sup> day from the required day. All references to "days" are based on calendar days unless otherwise stated. Shipments may be subject to customs delays in some countries. Additional day fees may apply.
2. The POSITIONING FEE is applicable for all shipments that originate from or are destined to any of the following locations: **BOG, DXB, EZE, GRU, HKG, ICN, LIM, MIA, NRT, SCL and SYD**. Refer to AC Absolute° Certified Locations List on our website.
3. The EXPRESS ORDER FEE will apply to all orders/changes made by the customer 3 or less business days prior to the lease start date. Where statutory holidays fall on weekdays, these will not be considered business days. Orders must be placed by 12:00 local time to allow sufficient time for processing.
4. The CHANGE ORDER FEE and CANCELLATION FEE:

5. The EXTENDED TENDER/RETRIEVAL FEE is per hour and per ULD. It is applicable for shipments that are tendered more than 12 hours prior to flight departure or that continue to remain at an Air Canada Cargo warehouse or with a ground handling agent more than 24 hours after flight arrival. This fee will not apply for shipments that are delayed for customs reasons in South America. This fee is separate and in addition to any storage charges which may be applicable as a result of shipments not being retrieved at destination within 24 hours.
6. Containers must be returned in the same condition in which they were released. In the event of damage (internal or external), and where it has been determined that such damage was caused by the customer, additional charges may apply.
7. For Envirotainer t2 containers: 16 D-Cell alkaline batteries, the applicable amount of dry ice and a copy of the Dry Ice Calculation Sheet are to be supplied by the customer at shipment origin. If/when batteries are required to be replaced, Air Canada Cargo will do so at the cost of USD 50\* per 16 batteries. If/when dry ice is required to be replenished, Air Canada Cargo will do so (calculations provided by customer) at a cost of USD 6/kg\* with a USD 100\* minimum.
8. If container preconditioning is required, a cost of USD 75\* per container may apply.
9. Container leases not booked directly through Air Canada Cargo are subject to a handling fee of USD 200.\*

\* Will be billed in USD or local currency equivalent at current exchange rates.
