



CLOSEST TO THE PIN
RULES AND REGULATIONS – 2018

1. The contest is open to all Canadian residents 18 years and older, except employees, directors, representatives and agents of Air Canada, its affiliates, Air Canada's advertising agencies, the judges, and the persons with whom any of the foregoing individual is domiciled.
2. The contest commences at 00:01, local times, on May 7th, 2018, and closes at midnight, local times, on November 2nd, 2018 (the "Contest Period").
3. One prize will be awarded to each of the **three (3) persons** whose name will duly appear on the **"Air Canada Closest to the Pin" winner's registration form that will be randomly drawn.**
4. The participant's name will be entered under the following conditions:
 - When an eligible golf tournament (duly registered with Air Canada prior to October 5, 2018) is held during the Contest Period at the course and where the entrant has legally won the designated "Closest to the Pin" par challenge; and
 - When the entry form is returned to the Air Canada address indicated thereon so as it is received at the latest before 17h00 EST November 16th, 2018.
 - No purchase necessary.
5. The draw will take place at Air Canada's head office in Montreal, 7373 Cote Vertu Boulevard West, Saint-Laurent, Québec, at 14h00 EST on November 19th, 2018, from all eligible entries received.
6. A total of three (3) prizes will be drawn, each consisting of:
Two round-trip regularly scheduled economy class tickets on any flight operated by Air Canada (including, flights operated under the Air Canada Express banner and operated by Air Canada rouge) from the major airport served by Air Canada closest to the winner's residence and to any destinations in North America (including Hawaii and Mexico) and the Caribbean, served by Air Canada (excluding codeshare and charter flights).
 - Approximate value of each prize is \$3,154.00
 - One prize per winner only.
 - Value of prizes may vary depending on points of departure and/or destination of a given flight. Total approximate value of all prizes: \$9,462.00. Winners of the prizes described above are responsible for payment of any taxes.
7. A representative of Air Canada will communicate, by telephone or by mail, with the selected entrants as indicated on the entry form.
8. In order to be declared a winner, the selected entrant will be asked to:
 - i) correctly answer unaided a time limited mathematical skill question to be administered by phone at a mutual agreed upon time.
 - ii) to sign a declaration and release form stating that they have read, understood and complied with the rules and regulations of the contest and that they accept the prizes as awarded; and

iii) to sign a discharge of responsibility to Air Canada's satisfaction.

Once the declaration and discharge have been executed and the selected entrant has been deemed a prize winner, he/she will receive a letter from Air Canada by regular mail with instructions on how to reserve his/her plane tickets and redeem the prize.

9. Transportation to and from an Air Canada served airport, accommodation, alcoholic beverages, insurance, taxes, surcharges and any other expenses not specifically mentioned herein are not included. Except as otherwise specifically provided, all airline tickets awarded or redeemed in this promotion are valid for travel between December 1, 2018 and December 16, 2019. Reservations are subject to availability at time of booking and some blackout periods apply.
